## **TERMS AND CONDITIONS**

Diogo Dalot Signed Shirt Prize Draw

### **Entry**

- Manchester United Football Club Limited ("MU") (whose registered office is Old Trafford, Sir Matt Busby Way, Manchester M16 0RA) is the promoter of the Diogo Dalot Signed Shirt prize draw (the "Prize Draw").
- 2. By entering the Prize Draw entrants agree to be bound by these terms and conditions ("Conditions") and confirm that all information submitted is true, accurate and complete. MU reserves the right to verify the eligibility of any and all entrants and may, in its sole discretion, disqualify any entrant that fails to satisfy the eligibility requirements. Entrants shall at all times act in good faith towards MU and the Prize Draw.
- 3. Employees of MU or any of its associated companies or subsidiaries (and their families) are excluded from entering the Prize Draw.

  - (v) via any other method of entry which MU makes available.
- 6. The Prize Draw will close at 23:59 British Summer Time on Saturday 16 June 2018 (the "Closing Date") and any entries received after the Closing Date will not be entered into the Prize Draw. The Prize Draw will take place as soon as reasonably practicable following the Closing Date.

# **Prize**

- 7. Subject to paragraphs 8 and 9, the prize will consist of a Manchester United Season 2017/18 home football shirt signed by Diogo Dalot (the "**Prize**"). Any details as to the style or size of the shirt forming the Prize will be at MU's absolute discretion.
- 8. MU reserves the right to substitute the Prize with another of a similar nature at any time.
- 9. The Prize is non-transferable and there is no cash alternative.

### Winner

10. The winner will be the first person selected at random from all valid entries received on or before the Closing Date (the "Winner"). The Winner will receive the Prize.

- 11. Only the Winner will receive notification from MU. The Winner will be notified by email as soon as practicable after the Closing Date. Following the draw, the Prize will be posted to the Winner.
- 12. The Winner (or the Winner's parent or guardian if the Winner is under 16 years of age) will be required to give their consent to the following: (i) for the Winner's name to be disclosed to any person requesting that MU confirms the identity of the Winner; and (ii) for the Winner's name and/or photograph to be published for promotional purposes.
- 13.
