

TERMS AND CONDITIONS

Manchester United Women's Team Signed Shirt Prize Draw

Entry

1. Manchester United Football Club Limited ("**MU**") (whose registered office is Old Trafford, Sir Matt Busby Way, Manchester M16 0RA) is the promoter of the Manchester United Women's Team Signed Shirt prize draw (the "**Prize Draw**").
2. By entering the Prize Draw entrants agree to be bound by these terms and conditions ("**Conditions**") and confirm that all information submitted is true, accurate and complete. MU reserves the right to verify the eligibility of any and all entrants and may, in its sole discretion, disqualify any entrant that fails to satisfy the eligibility requirements. Entrants shall at all times act in good faith towards MU and the Prize Draw.
3. Employees of MU or any of its associated companies or subsidiaries (and their families) are excluded from entering the Prize Draw.
4. Entry into the Prize Draw is free (except for any applicable data usage charges) and on the basis of one entry per person.
5. In order to enter the Prize Draw and to be considered for the Prize, entrants must complete the relevant data entry fields for the Prize Draw:
 - i. through the "Competition" Facebook application;
 - ii. via www.manutd.com;
 - iii. in the overlay form available at www.manutdfans.cn;
 - iv. on the official Manchester United accounts on the following social media platforms: (a) Facebook; (b) Twitter; (c) Wechat; (d) Sina Weibo; (e) Tencent Weibo; (f) LINE; or
 - v. via any other method of entry which MU makes available.
6. The Prize Draw will close at 23:59 GMT on Sunday 22 July 2018 (the "**Closing Date**") and any entries received after the Closing Date will not be entered into the Prize Draw. The Prize Draw will take place as soon as reasonably practicable following the Closing Date.

Prize

7. Subject to paragraph 8 the prize will consist of one Manchester United Women's team shirt signed by member(s) of the Manchester United Women's team (the "**Prize**"). Any details as to the number, style, or size of the shirt forming the Prize will be at MU's absolute discretion. MU gives no guarantee that the Prize will be signed by any particular Manchester United Women's team player. MU will not enter into any correspondence as to which Manchester United Women's team player(s) sign(s) the Prize.
8. MU reserves the right to substitute the Prize with another of a similar nature at any time.
9. The Prize is non-transferable and there is no cash alternative.

Winner

10. The winner will be the first person selected at random from all valid entries received on or before the Closing Date (the "**Winner**"). The Winner will receive the Prize.
11. Only the Winner will receive notification from MU. The Winner will be notified by email as soon as practicable after the Closing Date. Following the draw, the Prize will be posted to the Winner.
12. The Winner will be required to give their consent to the following: (i) for the Winner's name to be disclosed to any person requesting that MU confirms the identity of the Winner; and (ii) for the Winner's name and/or photograph to be published for promotional purposes, although the Winner may raise any concerns regarding this paragraph 12 with MU.
13. If MU cannot successfully contact the Winner within a reasonable length of time, or if the Winner is unable or unwilling to accept the Prize, or if the Winner does not meet the eligibility requirements, or if the Winner does not provide the consent requested at paragraph 12 above, subsequent draws will take place until a new winner is found who is able, willing and eligible to accept the Prize and provide the necessary consents. This new winner shall be deemed to be the Winner for the purposes of these Conditions.
14. Subject to paragraphs 12 and 13 above, details of the Winner will be made available to the public upon request from Manchester United Football Club Limited, Sir Matt Busby Way, Old Trafford, Manchester M16 0RA two weeks after the Closing Date (subject to data protection legislation).

General

15. MU reserves the right to cancel or amend the Prize Draw or these Conditions without notice when reasonably necessary for the purpose of administering the Prize Draw.
16. The Prize Draw, together with these Conditions, is governed by the laws of England and Wales and shall be subject to the exclusive jurisdiction of the English courts.
