TERMS AND CONDITIONS

Tour 2018 – Match Bundle Prize Draw

Entry

- Manchester United Football Club Limited ("MU") (whose registered office is at Old Trafford, Sir Matt Busby Way, Manchester M16 0RA) is the promoter of the Tour 2018 – Match Bundle prize draw (the "Prize Draw").
- 2. By entering the Prize Draw entrants agree to be bound by these terms and conditions ("**Conditions**") and confirm that all information submitted is true, accurate and complete. MU reserves the right to verify the eligibility of any and all entrants and may, in its sole discretion, disqualify any entrant that fails to satisfy the eligibility requirements. Entrants shall at all times act in good faith towards MU and the Prize Draw.
- 3. Employees of MU or any of its associated companies or subsidiaries (and their families) are excluded from entering the Prize Draw.

Prize

7. Subject to paragraphs 10 and 11, each winner of a Prize Draw will receive:

- One Manchester United shirt worn by a member of the Manchester United Tour Squad (the "Squad") during a tour match and signed by a member of the Squad;
- (ii) One Manchester United shirt signed by member(s) of the Squad;
- (iii) One Tour Legends card signed by member(s) of the Squad; and
- (iv) One Mlily travel pillow,

(each a "Prize" and together the "Prizes").

- 8. Any details as to the number, style or size of any of the Prizes or, where applicable, the Substitute Prize, will be at MU's absolute discretion.
- 9. The Manchester United player(s) who sign(s) any shirt or other item(s) forming part of the Prizes will be at MU's absolute discretion. MU gives no guarantee that any of the Prizes or, where applicable, the Substitute Prize, will be signed by any particular Manchester United player(s). MU will not enter into any correspondence as to which Manchester United player(s) sign(s) any of the Prizes or, where applicable, the Substitute Prize.
- MU reserves the right to substitute any Prize with another of a similar nature at any time. In particular, the Prize listed at paragraph 7(i) may, at MU's absolute discretion, be substituted for one Manchester United shirt signed by a member of the Squad (the "Substitute Prize").
- 11. The Prizes and, where applicable, the Substitute Prize, are non-transferable and there is no cash alternative.

Winner

- 12. There will be five winners of the Prizes (one for each Prize Draw). The winners will be the first five people selected at random from all valid entries received between the Opening Time and the Closing Time for each relevant Prize Draw (each a "Winner" and together the "Winners"). Each winner of a Prize Draw will receive the Prizes and, where applicable, the Substitute Prize.
- 13. Only the Winners will receive notification from MU. The Winners will be notified by email as soon as practicable after the Closing Date. Following the draw, the Prizes and, where applicable, the Substitute Prize, will be posted to the Winners.
