TERMS AND CONDITIONS

2018/19 Season Signed Home Shirt and Full Home Kit Prize Draw

Entry

- Manchester United Football Club Limited ("MU") (whose registered office is Old Trafford, Sir Matt Busby Way, Manchester M16 0RA) is the promoter of the 2017/18 Season Signed Home Shirt and Full Home Kit Prize Draw (the "Prize Draw").
- 2. By entering the Prize Draw entrants agree to be bound by these terms and conditions ("**Conditions**") and confirm that all information submitted is true, accurate and complete. MU reserves the right to verify the eligibility of any and all entrants and may, in its sole discretion, disqualify any entrant that fails to satisfy the eligibility requirements. Prize

(together the "Prize").

8. The Manchester United players who sign the Signed Shirt Prize and any details as to the number, style or squad designation (as applicable) of the item(s) of clothing forming the Signed Shirt Prize and/or the Kit Prize will be at MU's absolute discretion.

MU gives no guarantee that the Signed Shirt Prize will be signed by a particular Manchester United player. MU will not enter into any correspondence as to which Manchester United player) sign the Signed Shirt Prize.

- 9. MU reserves the right to substitute any Prize with another of a similar nature and/or of equal or greater value at any time.
- 10. The Prize is non-transferable and there is no cash alternative.

Winner

- 11. The winner will be the first person selected at random from all valid entries received on or before the Closing Date (the "**Winner**"). There will be one Winner who will win the Prize.
- 12. Only the Winner will receive notification from MU. The Winner will be notified by email as soon as practicable after the Closing Date. Following the draw, and following the first player signing session after the summer, the Prize will be posted to the Winner.
- 13.
