TERMS AND CONDITIONS

18/19 Season - Man of the Match - Juventus Away Prize Draw

Entry

- Manchester United Football Club Limited ("MU") (whose registered office is Old Trafford, Sir Matt Busby Way, Manchester M16 0RA) is the promoter of the 18/19 Season – Man of the Match – Juventus prize draw (the "Prize Draw").
- 2. By entering the Prize Draw entrants agree to be bound by these terms and conditions ("Conditions") and confirm that all information submitted is true, accurate and complete. MU reserves the right to verify the eligibility of any and all entrants and may, in its sole discretion, disqualify any entrant that fails to satisfy the eligibility requirements. - 6. The Prize Draw will close at 23:59 GMT three calendar days after the date of the relevant fixture (the "Closing Date") and any entries received after the Closing Date will not be entered into the Prize Draw. The Prize Draw will take place as soon as reasonably practicable following the Closing Date.

Prize

- 7. Subject to paragraph 8 the prize will consist of either a 2018/19 Manchester United home or away shirt or 3rd shirt signed by the relevant fixture's man of the match (the "**Prize**"). Any details as to the number, style, squad designation or size of the shirt forming the Prize will be at MU's absolute discretion.
- 8. MU reserves the right to substitute the Prize with another of a similar nature at any time.
- 9. The Prize is non-transferable and there is no cash alternative.

Winner

10. The winner will be the first person selected at random from all valid entries received on or before the Closing Date (the "Winner"). The Winner will receive the Prize.

- 11. Only the Winner will receive notification from MU. The Winner will be notified by email as soon as practicable after the Closing Date. Following the draw, the Prize will be posted to the Winner.
- 12. The Winner will be required to give their consent to the following: (i) for the Winner's name to be disclosed to any person requesting that MU confirms the identity of the Winner; and (ii) for the Winner's name and/or photograph to be published for promotional purposes, although the Winner may raise any concerns regarding this paragraph 12 with MU.
- 13.
