# TERMS AND COND ITIONS Manchester United Black Friday Prize Pool Prize Draw

# Entry

- Manchester United Football Club Limited ("MU") (whose registered office is Old Trafford, Sir Matt Busby Way, Manchester M16 0RA) is the promoter of the Manchester United Black Friday Prize Pool prize draw (the "Prize Draw").
- 2. By entering the Prize Draw entrants agree to be bound by these terms and conditions ("**Conditions**") and confirm that all information submitted is true, accurate and complete. MU reserves the right to verify the eligibility of any and all entrants and may, in its sole discretion, disqualify any entrant that fails to satisfy the eligibility requirements. Entrants shall at all times act in good faith towards MU and the Prize Draw.
- 3. Employees of MU or any of its associated companies or subsidiaries (and their families) are excluded from entering the Prize Draw.
- 4. Entry into the Prize Draw is free (except for any applicable data usage charges) and on the basis of one entry per person.
- 5. In order to enter the Prize Draw and to be considered for the Prize, entrants must complete the relevant data entry fields for the Prize Draw by clicking on the Prize Draw entry link available:
  - (i) through the "Competition" Facebook application;
  - (ii) via www.manutd.com;
  - (iii) in the overlay form available at www.manutdfans.cn;
  - (iv) on the official Manchester United accounts on the following social media platforms: (a) Facebook; (b) Twitter; (c) Wechat; (d) Sina Weibo; (e) Tencent Weibo; (f) LINE; or
  - (v) via any other method of entry which MU makes available.
- 6. The Prize Draw will close at 23:59 GMT on Sunday 2 December 2018 (the "Closing Date") and any entries received after the Closing Date will not be entered into the Prize Draw. The Prize Draw will take place as soon as reasonably practicable following the Closing Date.

### Prize

- 7. Subject to paragraphs 8 to 17 (inclusive) below, the prize will consist of:-
  - (i) a signed Manchester United 2018/2019 home shirt;
  - (ii) a free 2018/19 Official Manchester United Membership (the "Membership") for the period from the date on which the Winner is selected following the Closing Date until 31 May 2019 (the "Membership Period") (only Membership for the Membership Period will be free of charge);
  - (iii) a Membership for the Membership Period for another individual nominated by the Winner;
  - (iv) a free subscription to MUTV for the period of 12 months from the date when the Winner signs up to MUTV (the "**MUTV Subscription**") (only the subscription for

the period of 12 months after the Winner signs up (the "**Subscription** Period") will be free of charge);

- (v) a free pass for the Manchester United museum (located within the Old Trafford football stadium (the "Stadium") and Stadium tour (the "Museum and Tour Pass") for the period of 12 months from the date when the Winner signs up to receive the Museum and Tour Pass;
- (vi) a Museum and Tour pass for the same 12 month period as the Winner's Museum and Tour Pass for another individual nominated by the Winner;
- (vii) two matchday hospitality tickets (one for the Winner and one for their guest) to a Manchester United match to be held at the Stadium during the remaining 2018/19 football season (matchday hospitality tickets are subject to availability and the match will be chosen by MU in its absolute discretion);
- (viii) two standard general admission tickets (one for the Winner and one for their guest) to a Manchester United Women's football team home game of the Winner's choice (subject to availability) taking place during the remaining 2018/19 football season;
- (ix) a bundle of Manchester United related items including, an A3 calendar, a 2019 diary, a 2019 desk easel, a Soccer Starz 2018/19 team line-up set; and a 3D Stadium BRXLZ construction kit; and
- (x) a £100 voucher which can be used on Manchester United's official online megastore "United Direct" at <u>https://store.manutd.com/stores/manutd/en</u> (the "Voucher") (terms and conditions apply to use of Voucher).<sup>1</sup>

(each a "Prize" and together the "Prizes").

- The Official Manchester United Terms & Conditions of Membership Season 2018/19 (available on request from Ticketing & Membership Services and at <u>www.manutd.com/termsandconditions</u>) and the Official Manchester United MUTV Terms and Conditions (available at <u>www.manutd.com/termsandconditions</u>) both apply apply to the recipient of the Prize.
- The Matchday VIP Hospitality Ticket Terms and Conditions Season 2018/19 (available on request from Ticketing & Membership Services and at <u>www.manutd.com/termsandconditions</u>) apply to the Winner's and their guest's use of the facilities at the Stadium.
- 10. The Manchester United Football Club Museum & Stadium Tour Terms and Conditions (available on request from Ticketing & Membership Services and at <u>www.manutd.com/termsandconditions</u>) apply to the Winner of the Prizes and to the individual nominated by the Winner to receive a Museum and Tour Pass.
- 11. The MUTV Digital Terms and Conditions (available on request from Ticketing & Membership Services and at <u>www.manutd.com/termsandconditions</u>) apply to the Winner's use of the MUTV Subscription.
- 12. The Winner and their chosen guest will be required to comply with any policies, procedures, ground regulations, terms, conditions and/or reasonable requirements of MU and/or of the venue hosting the Manchester United Women's football team home game which the Winner chooses to attend.

- 13. MU reserves the right to substitute any Prize with another of a similar nature and/or of equal or greater value at any time.
- 14. The Prizes are non-transferable and there is no cash alternative.
- 15. Any details as to the number or size of the shirt that forms part of the Prizes, referred to at paragraph 7 (i) above will be at MU's absolute discretion. MU gives no guarantee that the shirt that forms part of the Prizes, referred to at paragraph 7 (i) above, will be signed by any particular Manchester United player(s) and MU will not enter into any correspondence as to which Manchester United player(s) will sign it.
- 16. The Voucher must be used by the Winner by 23:59 GMT on 1 March 2019 after which time it will expire.
- 17. Any ancillary costs and expenses associated with the Prizes (including, but not limited to, subsistence and/or travel costs) are not included and shall be borne by the Winner and their guest(s).

#### Winner

- 18. The winner will be the first person selected at random from all of the entries received on or before the Closing Date (the "**Winners**"). The Winner will receive the Prizes.
- 19. Only the Winner will receive notification from MU. The Winner will be notified by email or telephone as soon as practicable after the Closing Date. Following the draw, the Prizes will be posted to the Winner or made available for collection at the Stadium.
- 20. If the Winner of the Prizes is under 18 years of age, the Winner's parent or guardian will be required to: (i) accompany the Winner to all of the football games to which the Winner has won tickets and (ii) consent to the Winner accepting all of the Prizes.

### The Membership

- 21. The Memberships that form the Prizes may be renewed for the following season (2019/2020). The Winner and their nominee will be given the option to agree to renew the Memberships for the 2019/2020 season (which may include by providing bank details and agreeing to an automatic renewal). The Winner and the nominee will be contacted by MU at various times between the Closing Time and the 1 June 2019, in a manner as specified by MU, in connection with renewing the Membership for the 2019/2020 season. If a Winner or their nominee agrees to the renewal of their respective Membership for the 2019/2020 season, the Winner or their nominee will then be charged a fee in accordance with the Official Manchester United Terms & Conditions of Membership.
- 22. Following the Closing Date, the Winner will be given instructions of how to nominate an individual to receive the Membership that forms part of the Prizes, referred to at paragraph 7 (iii) above.

### The MUTV Subscription

23. The Winner will be given the option to agree to renew the MUTV Subscription for another 12 months at the end of the Subscription Period (which may include by providing bank details and agreeing to an automatic renewal). The Winner will be contacted by MU at various times between the Closing Time and the end of the Subscription Period, in a manner as specified by MU, in connection with renewing the MUTV subscription beyond the Subscription Period. If a Winner agrees to the renewal of the MUTV Subscription beyond the Subscription Period, the Winner will then be charged a fee in accordance with the MUTV Digital Terms and Conditions.

### **Contacting the Winner**

- 24. The Winner (or the Winner' parent or guardian if the Winner is under 16 years of age) will be required to give their consent to the following: (i) for the Winner name to be disclosed to any person requesting that MU confirms the identity of the Winner; and (ii) for the Winner's name and/or photograph to be published for promotional purposes.
- 25. If MU cannot successfully contact the Winner within a reasonable length of time, or if the Winner is unable or unwilling to accept the Prize, or if the Winner does not meet the eligibility requirements, or if the Winner (or the parent or guardian of the Winner if the Winner is under 16 years of age) does not provide the consent requested at paragraph 24 above, subsequent draws will take place until a new winner is found who is able, willing and eligible to accept the Prize and provide the necessary consents. This new winner shall be deemed to be the Winner for the purposes of these Conditions.
- 26. Subject to paragraphs 24 and 25 above, details of the Winner will be made available to the public upon request from Manchester United Football Club Limited, Sir Matt Busby Way, Old Trafford, Manchester M16 0RA two weeks after the Closing Date (subject to data protection legislation).

### General

- 27. MU reserves the right to cancel or amend the Prize Draw or these Conditions without notice when reasonably necessary for the purpose of administering the Prize Draw.
- 28. The Prize Draw, together with these Conditions, is governed by the laws of England and Wales and shall be subject to the exclusive jurisdiction of the English courts.
