

## TERMS AND CONDITIONS

### Aaron Wan-Bissaka Signed Football Boots Prize Draw

#### Entry

1. Manchester United Limited Football Club Limited ("**MU**") (whose registered office is Old Trafford, Sir Matt Busby Way, Manchester M16 0RA) is the promoter of the Aaron Wan-Bissaka Signed Football Boots Prize Draw (the "**Prize Draw**").
2. By entering the Prize Draw entrants agree to be bound by these terms and conditions ("**Conditions**") and confirm that all information submitted is true, accurate and complete. MU reserves the right to verify the eligibility of any and all entrants and may, in its sole discretion, disqualify any entrant that fails to satisfy the eligibility requirements. Entrants shall at all times act in good faith towards MU and the Prize Draw.
3. Employees of MU or any of its associated companies or subsidiaries (and their families) are excluded from entering the Prize Draw.
4. Entry into the Prize Draw is free (except for any applicable data usage charges) and on the basis of one entry per person (subject to paragraph 6 below), and is open to persons aged 16 and over at the time of entry.
5. In order to enter the Prize Draw and to be considered for the Prize, entrants must complete the relevant data entry fields for the Prize Draw by clicking on the Prize Draw entry link available:
  - (i) via [www.manutd.com](http://www.manutd.com) or [www.manutdfans.cn](http://www.manutdfans.cn) (for entrants located in China);
  - (ii) through MU's social media accounts (including its official Facebook, Instagram and Twitter pages);
  - (iii) on the link provided on the official Manchester United accounts on the following social media platforms: (a) WeChat; (b) Sina Weibo; and/or (c) Tencent Weibo; or
  - (iv) via any other method of entry which MU makes available,(the "**Main Entry**").
6. Subject to paragraph 7 below, in addition to the Main Entry, entrants are also eligible to gain one further automatic entry into the Prize Draw by: (i) downloading the Manchester United Official App (the "**App**"); and (ii) registering themselves within the App. A link to download the App will be made available to entrants following the making of the Main Entry. Any person who makes a Main Entry who is already registered within the App prior to the commencement of this Prize Draw will automatically obtain one additional entry into the Prize Draw.
7. Downloading, using and accessing the App is subject to terms and conditions which are available on application stores or third party platforms on which the App is made available to download (the "**App Terms and Conditions**"). Entrants into this Prize Draw (or an entrant's parent or guardian if an entrant is under 18 years of age) are required to read and agree to the App Terms and Conditions prior to downloading, using or accessing the App.
8. The Prize Draw will close at 23:59 BST on Sunday 18 August 2019 (the "**Closing Date**") and any entries received after the Closing Date will not be entered into the Prize Draw. The Prize Draw will take place as soon as reasonably practicable following the Closing Date.

## **Prize**

9. Subject to paragraph 10 the prize will consist of one pair of adidas Nemeziz football boots, signed by Aaron Wan-Bissaka. Any details as to the size or colour of the boots forming the Prize will be at MU's absolute discretion.
10. MU reserves the right to substitute the Prize with another of a similar nature at any time.
11. The Prize is non-transferable and there is no cash alternative.

## **Winner**

12. There will be one winner of the Prize Draw. The winner will be the first person selected at random from all valid entries received on or before the Closing Date (the "**Winner**").
13. Only the Winner will receive notification from MU. The Winner will be notified by email as soon as practicable after the Closing Date. Following the draw, the Prize will be posted to the Winner.
14. The Winner (or the Winner's parent or guardian if the Winner is under 16 years of age) will be required to give their consent to the Winner's surname and country to be disclosed to any person requesting that MU confirms the identity of the Winner, and for promotional purposes.
15. If MU cannot successfully contact the Winner within a reasonable length of time, or if the Winner is unable or unwilling to accept the Prize, or if the Winner does not meet the eligibility requirements, or if the Winner (or the parent or guardian of the Winner if the Winner is under 16 years of age) does not provide the consent requested at paragraph 14 above, subsequent draws will take place until a new winner is found who is able, willing and eligible to accept the Prize and provide the necessary consents. This new winner shall be deemed to be the Winner for the purposes of these Conditions.
16. Subject to paragraphs 14 and 15 above, details of the Winner's surname and country will be made available to the public upon request from Manchester United Football Club Limited, Sir Matt Busby Way, Old Trafford, Manchester M16 0RA two weeks after the Closing Date (subject to data protection legislation).

## **General**

17. MU reserves the right to cancel or amend the Prize Draw or these Conditions without notice when reasonably necessary for the purpose of administering the Prize Draw.
18. The Prize Draw, together with these Conditions, is governed by the laws of England and Wales and shall be subject to the exclusive jurisdiction of the English courts.
