

## TERMS AND CONDITIONS

### 2019/2020 Season – Win a Signed Shirt Man of the Match Prize Draw

#### The Prize Draws

1. Manchester United Football Club Limited (“**MU**”) (whose registered office is Old Trafford, Sir Matt Busby Way, Manchester M16 0RA) is the promoter of the 2019/2020 Season – Win a Signed Shirt Man of the Match Prize Draws (the “**Prize Draws**”).
2. MU will launch a Prize Draw each and every time that the Manchester United first team squad wins a Premier League game during the 2019/2020 Premier League football season (a “**Winning Match**”) (each a “**Prize Draw**” and together the “**Prize Draws**”). MU will run the Prize Draws throughout the Premier League Season 2019/2020 until the Ultimate Closing Date.
3. Provided entry is in accordance with these Conditions, entrants may enter any or all of the Prize Draws throughout the Premier League Season 2019/2020.

#### Entry

4. By entering the Prize Draws, entrants agree to be bound by these terms and conditions (“**Conditions**”) and confirm that all information submitted is true, accurate and complete. MU reserves the right to verify the eligibility of any and all entrants and may, in its sole discretion, disqualify any entrant that fails to satisfy the eligibility requirements. Entrants shall at all times act in good faith towards MU and the Prize Draws.
5. Employees of MU or any of its associated companies or subsidiaries (and their families) are excluded from entering the Prize Draws.
6. Entry into a Prize Draw is free (except for any applicable data usage charges) and on the basis of one Main Entry (and one Extra Entry, as applicable) per person per Prize Draw.
7. In order to enter a Prize Draw and to be considered for a Prize, entrants must complete the relevant data entry fields for the Prize Draw by clicking on the Prize Draw entry link available:
  - i. via [www.manutd.com](http://www.manutd.com);
  - ii. in the overlay form available at [www.manutdfans.cn](http://www.manutdfans.cn);
  - iii. on the following official Manchester United accounts on the following social media platforms: (a) Facebook; (b) Twitter; (c) Wechat; (d) Sina Weibo; (e) Tencent Weibo; (f) LINE; or
  - iv. via any other method of entry which MU makes available,(the “**Main Entry**”).
8. Subject to paragraph 9 below, in addition to the Main Entry, entrants are also eligible to gain one further automatic entry into a Prize Draw by: (i) downloading the Manchester United Official App (the “**App**”); and (ii) registering themselves within the App (an “**Extra Entry**”). A link to download the App will be made available to entrants following the making of the Main Entry. For the avoidance of doubt, any person who makes a Main Entry and who is already registered within the App prior to the commencement of the relevant Prize Draw will automatically obtain one Extra Entry into the relevant Prize Draw.

9. Downloading, using and accessing the App is subject to terms and conditions which are available on the application stores or third party platforms on which the App is made available to download (the "**App Terms and Conditions**"). Entrants who wish to obtain an Extra Entry in accordance with paragraph 8 (or an entrant's parent or carer if an entrant is under 18 years of age) are required to read and agree to the App Terms and Conditions prior to downloading, using or accessing the App.
10. The relevant Prize Draw will open immediately after each Winning Match and will close at 23:59 GMT two days thereafter (the "**Closing Date**"). Any entries received after the Closing Date will not be entered into the Prize Draw. Each Prize Draw will take place as soon as reasonably practicable following each relevant Closing Date. No Prize Draws will take place after 24 May 2020 (the "**Ultimate Closing Date**").

### **Prize**

11. Subject to paragraph 12, the prize for each Prize Draw will consist of a 2019/2020 Manchester United shirt signed by the Man of The Match at the relevant Winning Match (the "**Prize**"). Any details as to the number, style or size of the shirt forming the Prize will be at MU's absolute discretion.
12. MU reserves the right to substitute the Prize with another prize of a similar nature or equivalent or greater value at any time.
13. The Prize is non-transferable and there is no cash alternative.

### **Winner**

14. The winners will be the first people selected at random from all valid entries received on or before each Closing Date (each a "**Winner**" and together the "**Winners**"). Each Winner will receive a Prize.
15. Only a Winner will receive notification from MU. Each Winner will be notified by email as soon as practicable after the relevant Closing Date. Following the draw, the relevant Prize will be posted to the Winner.
16. Each Winner (or a Winner's parent or carer if the Winner is under 16 years of age) will be required to give their consent to their surname and country to be disclosed to any person requesting that MU confirms the identity of a Winner for promotional purposes, although a Winner may raise any concerns regarding this paragraph 16 with MU.
17. If MU cannot successfully contact a Winner within a reasonable length of time, or if a Winner is unable or unwilling to accept the Prize, or if a Winner (or the parent or carer of a Winner if a Winner is under 16 years of age) does not meet the eligibility requirements, or if the Winner does not provide the consent requested at paragraph 16 above, subsequent draws will take place until a new winner is found who is able, willing and eligible to accept the Prize and provide the necessary consents. This new winner shall be deemed to be a Winner for the purposes of these Conditions.
18. Subject to paragraphs 16 and 17 above, details of a Winner's surname and country will be made available to the public upon request from Manchester United Football Club Limited, Sir Matt Busby Way, Old Trafford, Manchester M16 0RA two weeks after the Closing Date (subject to data protection legislation).

### **General**

19. MU reserves the right to cancel or amend the Prize Draw or these Conditions without notice when reasonably necessary for the purpose of administering the Prize Draw.

20. The Prize Draw, together with these Conditions, is governed by the laws of England and Wales and shall be subject to the exclusive jurisdiction of the English courts.
