

## TERMS AND CONDITIONS

### My United Starting XI – Season 2019/2020 Prize Draw

#### Entry

1. Manchester United Football Club Limited (“**MU**”) (whose registered office is Old Trafford, Sir Matt Busby Way, Manchester M16 0RA) is the promoter of the My United Starting XI – Season 2019/2020 prize draw which gives fans the chance to enter multiple prize draws over the course of the 2019/20 Football Season (the “**Season**”) (the “**Prize Draw**”). The Prize Draw is sponsored by Tianyu Technology INC. (a company registered in the Philippines whose registered office is at 6795 Ayala Avenue, 1209 Makati City, Metro Manila, Philippines, trading as Yabo (“**Yabo**”).
2. By entering the Prize Draw entrants agree to be bound by these terms and conditions (“**Conditions**”) and confirm that all information submitted is true, accurate and complete. MU reserves the right to verify the eligibility of any and all entrants and may, in its sole discretion, disqualify any entrant who fails to satisfy the eligibility requirements. Entrants shall at all times act in good faith towards MU and the Prize Draw.
3. Employees of MU or Yabo or any of their associated companies or subsidiaries (and their families) are excluded from entering the Prize Draw.
4. Entry into the Prize Draw is free (except for any applicable data usage charges) and is open to: (i) entrants of all ages (although MU assumes that any entrants who are under the age of 18 have obtained parental consent to enter this Prize Draw and accept these Conditions); and (ii) both UK and non-UK residents.
5. To enter the Prize Draw entrants must complete the form available on the My Manchester United starting XI webpage located at: [www.manutd.com/startingeleven](http://www.manutd.com/startingeleven) (or via any other method of entry which MU makes available) and:
  - (i) enter a prediction as to: (a) which 11 Manchester United players will form the starting line up in respect of the relevant home or away Manchester United competitive first team match (the “**Match**”) and (b) the formation of the starting lineup\* (together the “**Prediction**”); and

  - (ii) complete certain data entry fields at the time of submitting their Prediction.

(an “**Entry**”).

6. The My United Starting XI registration page will: (i) be available at a reasonable time prior to the first Match of the Season to allow entrants to submit their Entries; and (ii) be updated the next working day (i.e. Monday to Friday) after a Match, allowing entrants to submit Entries in the build up to the next Match; and (iii) will close 65 minutes before the official kick-off time (subject to fixture changes) for the relevant Match. Any Predictions made by an entrant less than 65 minutes before the official kick-off time for the Match will not be accepted.
7. Once a Prediction has been submitted, entrants are not permitted to make any changes to the Prediction.

9. This Prize Draw will close after the final Match of the Season.

#### The Points System

10. Entrants will be awarded:
- (i) 3 points if they correctly predict the starting lineup<sup>1</sup>; and
  - (ii) 1 point if they correctly predict the formation of the starting lineup<sup>2</sup>.
11. The amount of points that any entrant may be awarded for each Match is capped at a maximum of 4 points.
12. All decisions as to whether a Prediction (or part of a Prediction) is correct will be determined by MU in MU's absolute discretion. MU will not enter into any correspondence with any entrants regarding their Prediction.
13. MU will maintain and publish a points table throughout the season (the "**Points Table**") which will be available at [www.manutd.com/startingeleven](http://www.manutd.com/startingeleven) and MU will update the Points Table after each Match within a reasonable number of days. MU does not warrant or guarantee that the contents of the Points Table will be accurate or accessible at all times.

### The Prize Draws

14. Entrants who comply with these Conditions and submit an Entry may be eligible to win a prize or prizes at various points throughout the Season in accordance with paragraph 15 below.
15. MU may conduct the following prize draws throughout the Season as follows:
- i) after each Match, entrants who score the highest number of points in respect of that Match (according to the Points Table) will be entered into a match by match prize draw and given the chance to win a Match Prize (as defined below)(the "**Match by Match Prize Draw**");
  - ii) at the end of each calendar month throughout the Season (i.e. August 2019 through to May 2020) entrants who have accumulated the most points in that month (according to the Points Table) will be entered into a monthly prize draw and given the chance to win a Monthly Prize (as defined below)(the "**Monthly Prize Draw**"); and
  - iii) at the end of the Season, entrants who have accumulated the highest number of points throughout the Season (according to the Points Table) will be entered into the season grand prize draw and given the chance to win the Grand Prize (as defined below) (the "**Season Grand Prize Draw**").
16. The decision as to which entrants have accumulated the highest number of points will be decided by MU, in MU's absolute discretion, by reference to the Points Table.

### The Prizes

17. MU intends (but does not guarantee) that the following prizes (the "**Prizes**") will be available to the winners of the prize draws:
- i) the prize for each Match by Match Prize Draw will be a Manchester United Season 2019/2020 home football shirt signed by one or more members of Manchester United First Team squad (the "**Match Prize**");

- ii) the prize for each Monthly Prize Draw will be: (a) a Manchester United Season 2019/2020 home football shirt signed by a member of the Manchester United management team (at MU's discretion); and (b) a Manchester United Season 2019/2020 home football shirt signed by one or more members of Manchester United First Team squad; and (c) a free one month subscription to MUTV.com (the "**Monthly Prize**"); and
  - iii) the prize for the Season Grand Prize Draw will be a trip to Manchester (for the winner of the Season Grand Prize Draw and their guest) including:
    - a. 3\* hotel accommodation selected by MU on a bed-and-breakfast basis for two people for two nights based on two adults (or, if the winner of the Grand Prize is under 16 years old, the winner and their carer) sharing a double or twin room (the "**Hotel**");
    - b. return flights to and from Manchester Airport in economy class for the winner of the Grand Prize and their guest (such times and dates to be mutually agreed by MU and the winner);
    - c. return transfers from Manchester Airport to the Hotel (to be arranged by MU);
    - d. £200 spending money;
    - e. the opportunity to observe a training session with MU's first team at the Aon Training Complex;
    - f. a Manchester United Season 2019/2020 home football shirt signed by one or more members of Manchester United First Team squad; and
    - g. a free one month subscription to MUTV.com  
(the "**Grand Prize**").
18. MU reserves the right to substitute a Prize (or any component of a Prize) with another of a similar nature and/or of equal or greater value at any time.
19. The Prizes (or any component of the Prizes) are non-transferable and there are no cash alternatives.
20. The Manchester United player(s) who sign(s) a shirt, forming part of a Prize and any details as to the number, or squad designation (as applicable) of any shirt will be at MU's absolute discretion. MU gives no guarantee that any shirt will be signed by a particular Manchester United player. MU will not enter into any correspondence as to which Manchester United player(s) sign(s) any shirt.
21. The winner of the Grand Prize and their guest:
- i) will be responsible for obtaining any requisite travel documents for travel to the UK including, but not limited to, a valid passport, visa, travel insurance or such other insurance as the winner and/or their guest may require);
  - ii) will be required to comply with any policies, procedures, terms, conditions, instructions and reasonable requirements of MU which are in place at the any of MU's facilities which the winner and their guest attend including, the Aon Training Complex; and
  - iii) are required to acknowledge that the date, timing and location of the opportunity to observe a training session will be subject to MU's ultimate

discretion and may be subject to changes and/or cancellation at the last minute.

### **The winners**

22. There will be numerous winners of the Prize Draw throughout the Season, as follows:
- i) the winner of each Match by Match Prize Draw will be the person who accumulates the highest number of points for the relevant Match. In the event of a draw, the entrants who hold the highest number of points will be entered into a ballot and the winner of that draw will be the first person selected at random. There will be one winner of each Match by Match Prize Draw following each Match;
  - ii) the winner of each Monthly Prize Draw will be the person who has accumulated the highest number of points in that month. In the event of a draw, the entrants who hold the highest number of points will be entered into a ballot and the winner of that draw will be the first person selected at random. There will be one winner of each of the Monthly Prize Draws; and
  - iii) the winner of the Season Grand Prize Draw will be the person who has accumulated the highest number of points overall for the Season. In the event of a draw, the entrants who hold the highest number of points will be entered into a ballot and the winner will be the first person selected at random. There will be one winner of the Season Grand Prize Draw and the Grand Prize;

(each a “**Winner**” and together the “**Winners**”).

23. Only the Winners will receive notification from MU. Each Winner will be notified by email as soon as practicable following the relevant prize draw and MU will make arrangements with the Winners about collection or delivery of their Prize.
24. MU may wish to use a Winner’s names for promotional purposes. Each Winner (or a Winner’s parent or carer if a Winner is under 16 years of age) will be required to give their consent to their surname and country to be disclosed to any person requesting that MU confirms the identity of the Winners and for promotional purposes. A winner may raise any concerns regarding this paragraph 24 with MU.
25. If MU cannot successfully contact a Winner within a reasonable length of time, or if a Winner is unable or unwilling to accept the Prize, or if a Winner does not meet the eligibility requirements, or if the winner of the Grand Prize is not permitted or unable to travel to the UK on the dates selected by MU or, if a Winner (or the parent or carer of a Winner, if a Winner is under 16 years of age) does not provide the consent requested at paragraph 24 above, subsequent draws will take place until a new winner is found who is able, willing and eligible to accept the relevant Prize and provide the necessary consents. This new winner shall be deemed to be a Winner for the purposes of these Conditions.
26. Subject to paragraphs 24 and 25 above, details of all of the Winners will be made available to the public upon request from Manchester United Football Club Limited, Sir Matt Busby Way, Old Trafford, Manchester M16 0RA two weeks after the Closing Date (subject to data protection legislation).

### **General**

27. There are no costs, fees or charges associated with entering this Prize Draw.
28. Entrants are responsible for any actions they do or do not take as a result of entering this Prize Draw.

29. MU reserves the right to cancel, amend or withdraw this Prize Draw or these Conditions (in whole or in part or, in certain jurisdictions only) without notice when reasonably necessary for the purpose of administering the Prize Draw.
30. The Prize Draw, together with these Conditions, are governed by the laws of England and Wales and shall be subject to the exclusive jurisdiction of the English courts.
